ORDER

WHEREAS, the institution namely, **K.S.R College of Education, K.S.R Kalvi Nagar, Thiruchengode, Namakkal District- 637209 Tamil Nadu** was granted recognition for offering B.Ed course vide SRC NCTE's order dated 28.09.2006 of one year duration with an intake of 100 students.

AND WHEREAS, on 19.1.2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 21.04.2015 offering B.Ed course of two years duration with an intake of 100 students (2 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

AND WHEREAS, the institution namely, **K.S.R College of Education, Khasara No. 207/1, 208/2, Erode Road, Kutchipalaya Village, KSR Kalvi Nagar, Tiruchengode Taluk, Namakkal District - 637215, Tamil Nadu** was granted recognition for offering **B.Ed-AI** course vide SRC NCTE's order dated 03.03.2015 of two year duration with an intake of 100 students.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 14.03.2019.

AND WHEREAS, the institution has submitted its reply on 10.09.2020.

AND WHEREAS, the matter was finally considered by the SRC in its 388th Virtual Meeting held from 14th - 15th September 2020 decided as under:

"On the perusal of the reply submitted by the institution vide letter dt 10.09.2020, the Committee decided that the **continuation order** be issued to the Institution **K.S.R College of Education, Namakkal District- 637209 Tamil Nadu** for following existing courses:-

- (i) **B.Ed - 4 units (50 students each unit).**
- (ii) **M.Ed- 1 unit of 50 students..."**

NOW THEREFORE, this order is issued permitting the institution **K.S.R. College of Education, S. No. 207/1B1, 207/1B2, 208/2B, K.S.R Kalvi Nagar, Thokkavadi Village, Tiruchengode, Namakkal District – 637215, Tamil Nadu** run by **Rajammal Rangaswamy Teacher Training Institute, No. 30B, East Muniyappan Kovil Street, Kumaresapuram, Tiruchengod – 637211, Salem District, Tamil Nadu** for continuation of conducting **B.Ed course** of two years duration with an annual intake of **4 basic units** (50 students each unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reser fund of Rs. 7 lakhs kept in joint account with Regional Director of No. : should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
5. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- c. Name of faculty members who left or joined during the last, quarter;
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
